#### 1) Enrolment procedure

- ▶ Photocopy of **2019** licence (if you haven't got a licence, you will be issued with one at the club. It costs **20€** and it is valid for one year.
- ▶ A Doctor's Certificate which doesn't prevent the trainee from practicing competitive sport (At enrolment, download the example on [tennislroux.com](http://tennislroux.com) and have it filled in and signed by your doctor.)
- ▶ A 30% down-payment, the balance must be paid, at the latest, 30 days before the beginning of the course
- ▶ Course cancellation or interruption Insurance is **optional**. This insurance covers sprains, muscle injuries, any sickness during the course etc... (see conditions) For fuller information, consult the contract.  
Arrival and departure form, as well as any eventual transport costs from Bordeaux Airport (**50€ or 70€** the return trip)

#### 1) Following your registration

You will receive an acknowledgment receipt of your application by email only if sent 3 weeks before the start of the course, sending more accused from 1 July 2019.

#### 2) Balance payment

You must settle your stay 30 days before the start of the course, without stimulus do our part. It will not be sent acknowledgment for the balance

#### 3) Cancellation

Call 06 19 56 01 45 to prevent, and must confirm by registered letter as soon as possible. If you cancel more than 30 days before the start date of the course, the deposit will be refunded, 15 to 30 days before the start of the course the deposit will be retained. If cancellation occurs 15 days before the start of the course 100% of the price of the course is maintained. If absence without prior cancellation, the full course is maintained. Any course started is due in full.

#### 4) Insurance cancellation and interruption of stay (Access-Mapfre Insurance / assistance)

This insurance will reimburse the compensation for breach of contract indicated above as requirements under the contract. Cancellation insurance and internship interruption is optional. The price of this insurance is to **35 €** per week per intern. See terms of repayments before and during the internship.

#### 5) The Franck Leroux Tennis Academy

Reserves the right to cancel a course, the number of participants allows the formation of a group. To modify the time provided for all relevant reasons for the smooth running of the course. In case the course is canceled, we will refund the full amount paid without further compensation.

#### 6) Medical fees

The medical expenses for illness or accident are sometimes advanced by Franck Leroux Tennis Academy. In this case, parents undertake to repay the sums advanced within a maximum period of one month after the date of stay.
